





Report on the POSOW Cyprus National Pilot Training



6 - 7 December 2013



Introduction

In May 2013, two Train the Trainer Courses were convened in Brest, France as a part of the Preparedness for Oil-polluted Shoreline cleanup and Oiled Wildlife interventions (POSOW) project (Task E)

POSOW aims at establishing a regional cooperation synergy through the enhancement of knowledge and capacities of operators (professionals and volunteers) in the field of marine pollution, in European coastal countries of the Mediterranean Sea, namely Croatia, Cyprus, France, Greece, Italy, Malta, Slovenia and Spain.

In order to create this regional synergy and build regional task forces of trainers, a training team (Civil Protection, regional / local authorities and specialized wildlife response NGO) received a dedicated Train the Trainer Course on Volunteer management, Oiled Shoreline Assessment and Cleanup and Oiled Wildlife Response.

National Training

Following the Train the Trainer Courses, a 3-day National Pilot Training Course was organized in each of the eight beneficiary countries. (Task F)

Volunteers from regions of each country were invited to participate in the course, with the contribution of the trainers previously trained during the Train the Trainer Courses. The course was attended by one representative of the project to support the regional entities involved.

The National Training in Cyprus was organized by the Civil Defense in cooperation with the NGO Terra Cypria, The Cyprus Conservation Foundation. Thirty-five (35) participants from different organizations (e.g. Civil Defense, NGO's, institutes etc), as listed in **Annex I** of the present report, attended the training course.

The program of the training reported in **Annex II** was spread over 2 days, without practical exercise. All material except for the manuals was previously translated into Greek. The presentations were delivered in Greek, except for the presentation on the overview of the project POSOW introduced in English by the Sea-Alarm partner.

The presentation by the Department of Fisheries about the National Response System was welcomed by the participants who get familiarized with the system in place. For many participants, this was a unique opportunity to discuss about the national contingency plan of their country and the required preparedness measures.

Upon completion, all participants were provided with a certificate and a USB Key containing all the material published by the POSOW Project.

The training course was held at the Cleopatra Hotel, Nicosia. During the breaks, all participants were given the opportunity to register on the POSOW volunteer database.

Evaluation of the training

After the last session on the second day, the participants were requested to fill in an evaluation sheet, reproduced in **Annex III** of the present report.

The following table summarizes the evaluation provided by 29 participants out of 35. The rating is based on a scale from 1 to 5, 1 being bad and 5 being excellent.

The more recurrent comments were:

- request for more practical examples or field and table tops exercises;
- Expect follow-up from the competent authorities on a better communication and collaboration between the acting parties;
- Need for further clarification on the role and type of volunteers in Cyprus.

The high interest of participants was demonstrated by numerous discussions and interactions between speakers and participants. Participants emphasized that it was the first time that environmental NGO's cooperated with the Civil Defense. A marine NGO is already interested to organize a second edition on the South coast of Cyprus
